

E.V. Pullias Endowed Scholarship Criteria (Continuing On-Campus Student Only)

POLICY STATEMENT: Awarded to currently enrolled students only. Awarded to students presently enrolled at Pepperdine University Graduate School of Education and Psychology in the Master of Arts in Education (MAE), Master of Arts in Teaching with Preliminary Teaching Credential (MAETP), Master of Science in Administration (ELA), Doctor of Education in Educational Leadership, Administration, and Policy (ELAP), Master of Arts in Learning Technologies (MALT), and Doctor of Education in Learning Technologies (DELT) programs. Eligibility is based on high academic merit and interest in the teaching profession. If awarded, an official notification will be sent to recipient(s) notifying them of the amount offered. The E.V. Pullias Endowed Scholarship is coordinated with all other financial aid, not to exceed the Cost of Attendance (COA). Students can apply for and receive more than one scholarship; however, the total award will not exceed 25% of tuition. This scholarship is not awarded in the summer semester.100% on-line (Psychology@Pepperdine) students are not eligible for this scholarship. For continuing on-campus students only.

- Eligibility for the E.V. Pullias Endowed Scholarship is based on a student submitting an application by the July 15 deadline. Applies to presently enrolled students only.
- 2. The recipients are chosen by a scholarship committee based on the E.V. Pullias Endowed Scholarship criteria.
- The E.V. Pullias Endowed Scholarship is tuition-specific and is awarded onetime only. The dollar amount varies and is awarded for the fall and spring terms.
- 4. The student must be enrolled full-time, based on Financial Aid standards for two consecutive terms in order to receive the scholarship. If the student does

not enroll at full-time status, he/she forfeits eligibility. The scholarship is not put on hold for any additional semester. Please note, any adjustments to awarded amounts will be at the University's discretion.

- 5. If a student withdraws, the scholarship will be revoked.
- 6. If a student takes a Leave of Absence, the scholarship will be revoked.
- 7. The student must remain in good academic standing with a GPA of 3.0 or higher in order to retain the Scholarship.
- 8. The E.V. Pullias Endowed Scholarship can be combined with other scholarships; however, the total award will not exceed 25% of tuition cost.
- 9. The Financial Aid Office receives the E.V. Pullias Endowed Scholarship awarding list from the scholarship committee.
- The Financial Aid Office awards the E.V. Pullias Endowed Scholarship, coordinating the scholarship with all other financial aid. If the awarding of the scholarship produces an over-award, federal student loans will be reduced first.
- 11. The Financial Aid Office sends the Offer of Financial Aid to the student.
 - a. The Offer of Financial Aid is used as a form of notification and confirmation of aid offered.
 - b. Students are required to acknowledge the Offer of Financial Aid on the student portal indicating their acceptance of the scholarship.
- 12. The Financial Aid Office applies the scholarship to the student's account at the start of the term.
- 13. Institutional scholarships cannot be refunded for cash value.
